TECHNOLOGY GRANT AWARDED TO HPF

In May, The Cameron Foundation approved a COVID-19 emergency grant of \$3,950 to HPF. This grant is for the purchase of technology equipment, audio-visual tools and software to help increase the technological capacity of HPF so that we may provide virtual programming amid the pandemic. HPF Board member Kyle Tucker is leading this project with two college interns. This is exciting new territory for HPF! Check out HPF's Facebook page for videos.

UPDATE ON THE EXCHANGE BUILDING PROJECT

On July 21, the Petersburg City Council unanimously adopted a Memorandum of Understanding (MOU) with HPF to allow us to proceed with the renovations at the Exchange Building. Last year, the National Park Service awarded HPF a \$350,000 Saving Americas Treasures grant to undertake the work. The Cameron Foundation made a matching grant of \$300,000 contingent on some conditions, including a working agreement with the City to support the project. As of this writing, how that support will be structured is still under discussion.

HPF has established an Oversight Committee, under the chairmanship of Martha Atkinson, to ensure the project is successful. A contract for additional investigation of the current condition of the building and refining the corrective measures needed is underway. This month, we will issue a Request for Proposal (RFP) for a team to undertake a Historic Structures Report (HSR). This document will provide the discoverable history of the building, its construction and use through time. Most importantly, it will also lay out the preservation priorities so the measures addressed in the grant application can be most effectively and efficiently accomplished.

This is a multi-year and multi-phase undertaking but will provide Petersburg with a much better understood and preserved National Historic Landmark. Public programs to share the information uncovered and plans made will be held. HPF is grateful to the National Park Service, the Cameron Foundation, the City and all who have assisted in getting this project approved and underway!

REPAIRS TO THE PETER JONES TRADING STATION



The time has come to address several issues at these stone ruins in the Old Towne Historic District. HPF plans to tackle the work in three phases and thanks to a grant from the Emma E. Bogart Trust, Bank of America, N.A., Trustee, work can begin soon.

PHASE 1 will be an immediate re-grading of the foundation to prevent groundwater from spilling along the eastern most wall. Years of this overflow have allowed the bricks to exfoliate and degrade. While this is not yet a structural concern, to leave it unaddressed will allow the deterioration to persist. HPF plans to channel the groundwater away from the building through grading the soil and gravel that meet the walls away from the structure. Then, using the natural grade to allow it to flow into the street gutters intended to channel storm water into the municipal drainage system. This process will require the temporary removal of the iron fencing currently in place and will allow for a rethinking of how best to position a fence to protect the building but also allow maximum public access to the building at the street grade along Grove Avenue.

PHASE 2 will address the exposed bricks in the existing endings of the standing walls.

These bricks were not intended to be exposed in this way and having them unsealed has allowed moisture, vegetation and other debris to get into the walls and the cavity encouraging and accelerating the deterioration of the bricks. With advice of preservation professionals, we will either seal the existing configuration using an appropriate lime mortar based concrete parge, or use additional historic bricks to finish off the walls with and end capped stepped off to approximate the contours of the existing ruin profile. Depending on the approach determined to be the most protective of the bricks with the least impact on the contours of the site, this may be a phase that extends beyond this first year.

PHASE 3 will enhance the existing parking area by removing existing vegetation that has encroached on the entire area, refreshing the gravel parking space and replacing concrete parking bumpers to better define the parking spaces available.

OUR NEW NEIGHBORS

In August, representatives of the Petersburg Chamber of Commerce approached HPF with the possibility of moving their operations across Washington Street into the Shirley T. VanLandingham Headquarters building. After many years at 325 East Washington Street, the Chamber decided to offer that building for sale and seek other administrative and meeting space. HPF has designed the renovation of 318-320 East Washington Street for just such an opportunity. We currently utilize the west side of the building for our administrative offices and occasionally use the upstairs rooms for Board and committee meetings.

In late August, after agreeing on lease terms, the Chamber moved across the street and now occupies the east side of the building. They also outfitted the two large upstairs rooms with conference tables that allow for a shared use of that meeting space. This opportunity spurred us to have several maintenance issues on our building addressed, including various wall repair and painting, rear door and deck repairs and ensuring that all HVAC units are functioning properly and efficiently. We continue to provide an administrative office for the Petersburg Preservation Task Force, now located on the second floor on the east side of the building.

Having the Chamber within the same building allows HPF to strengthen the partnership with that organization. The Chamber, founded in 1881, continues to build upon its 135 years of promoting economic vitality in the Petersburg region by fostering business growth; educating its members and the community; and advocating legislation to influence public policy. Pam Allen, current president of the Chamber stated "The move of the office will allow us to respond to the future demands of the Chamber while being intentional about building relevant programs and services for our members and the community. We will be located in the building with Historic Petersburg Foundation which allows us to continue to serve our members while partnering with another longstanding, reputable Petersburg non-profit."

While the initial least term is for one year, we look forward to a long and fruitful partnership with the Petersburg Chamber of Commerce.
